- In Indiana, an IEP team is referred to as a Case Conference Committee. 511 IAC 7-42-5
- Parents can request a Case Conference Committee at anytime throughout the school year. 511 IAC 7-42-5(a)(3)
- Article 7 is Indiana's version of Special Education law and is the same law the parent, school, and student must follow. 511 IAC 7-42-3
- The role of the parent is an <u>equal</u> member of the Case Conference Committee. 511 IAC 7-42-3(b)(5)
